## **Democratic National Convention - Delegate Training**

We are holding a training for LGBTQ Democrats interested in being a delegate to the Democratic National Convention in Milwaukee on July 13-16. We will discuss the process of choosing delegates, how to express interest to become a delegate, and what to expect when campaigning and if elected to represent your community at the DNC.

As part of the DFL and Democratic Partys' commitments to outreach & inclusion, **Minnesota has set a goal that at least 11 of its 97 delegates and alternates to the DNC be members of the LGBTQ+ community.** 

This training will center LGBTQ experiences and leadership, including discussion of what the Democratic Party's recently updated gender balance rules mean for queer, trans, and non-binary Democrats. However, the information presented in this training will be valuable for anyone interested in becoming a DNC delegate or making their own DFL party unit more welcoming for queer, trans, and non-binary DFLers.

- Membership Committee: manage membership engagement and outreach activities
- **Pride Committee**: plan Stonewall DFL participation in various Pride events across Minnesota
- **Fundraising Committee**: hold events to raise funds for Stonewall DFL and for endorsed candidates
- Communications Committee: strategic messaging + manage social media, email, website, and press
- Constitution & Bylaws Committee: review and improve governing rules and procedures

Most committees meet 6-10 a year, and all meetings will have remote participation via Zoom/conference call. Committees are composed of Stonewall DFL members, directors, and officers.
